Wednesday Sep. 30, the elected bargaining team had a last-minute meeting.

Management wants:

- Us to call off our strike and come back to the table to start all over again in a month or two
- To keep all of their takeaways
- To ignore our proposals to improve safety and staffing
- To bypass our elected bargaining team

The bargaining team met, and came to a simple conclusion: **we have been bargaining since January, and the only way we are calling off our strike is if we have a fair contract.** The bargaining team is ready, willing, and able to negotiate a fair deal at any time: before, during, or after our strike. To get us closer to this fair deal, we sent management a comprehensive proposal to resolve all outstanding issues. Our solidarity is getting results. **The strike is on. When we fight, we win!**
