### The Bargaining Team

Election Process

Every bargaining unit in the AHS Chapter is represented on the bargaining team.

Delegates for San Leandro Bargaining Unit will be elected at San Leandro only. Delegates for the General Unit and RN/ APP Unit will be elected by the following 5 work locations: Ambulatory, Fairmont, John George, Highland Core (nonambulatory). The highest vote recipients for each bargaining unit in each location will be delegates on the team.

The Election Committee will be responsible for resolving disputes related to the election, and will help administer balloting and election procedures. We are seeking volunteers for the Election Committee. NOTE: you cannot run for the bargaining team if you are on the Election Committee. #### NOTICE of ELECTION & NOMINATIONS

Oct. 7 - Oct. 21 The Notice will be posted on Union bulletin boards at your worksite(s). Any member may nominate themself or another member in their Chapter. The Election Committee will verify eligibility of each nomination.

#### POSTING of ELIGIBLE CANDIDATES & CAMPAIGNING

Oct. 28 - Nov. 13 Eligible candidates' names will be posted on AHSFight.org. The exact dates, times and locations of voting will also be posted on Union bulletin boards at your worksite(s) by October 9.

#### VOTING

Nov. 8 - 14 You must vote in person. Voting will take place at various worksites. There is NO proxy voting.

#### VOTE COUNT

#### Nov. 15

Ballots will be counted for all chapters on Nov. 15. The elected Bargaining Team members and alternates will be posted online at AHSFight.org.

## Requirements for SEIU 1021 Bargaining Team Members

- Must be a member of SEIU 1021.
- Must be willing and able to put in the time.
- Most meetings are during the day where you are released from work duties. Often the meetings go into the evening and are sometimes on weekends. If you are sick or unable to attend, you must call as soon as possible to be able to have an "alternate" replace you or some of our co-workers will go unrepresented.
- Must be willing to learn new things.
- Must represent all members, not just their bargaining unit, campus, or classification.
- Must be committed to sharing information with coworkers and work collaboratively with the Contract Action Team (CAT). This involves updates, meetings and listening as well as talking.

- Be a good communicator
- Be willing to assess risks and outcomes
- Be able to tolerate tense situations and conflict
